Spending Plan for \$300,000 Appropriation

The three Florida Children's Initiatives are jointly requesting a total of \$300,000 be appropriated to The Ounce of Prevention Fund of Florida through the Florida Department of Agriculture and Consumer Services, Fresh from Florida budget to help address the issues of food desserts and childhood obesity. The Ounce of Prevention Fund will serve as a fiscal agent and liaison/contractor to the Department of Agriculture, awarding sub-grants to approved Florida Children's Initiative programs, providing administrative oversight and contract compliance monitoring to include coordination and submission of required progress, data and outcome reports, and providing training and technical assistance as needed.

Miami Children's Initiative (Liberty City) \$95,000

Health and Wellness Coordinator ? MCI will hire a full-time health and wellness coordinator and will also scale-up and begin measuring the impact of MCI's health and wellness programs on an estimated 200 children. This will include:

- ? Measuring participating children's health data (e.g. BMI, weight, height, blood pressure, health knowledge, youth fitness metrics)

- ? Engaging children in robust fitness activities including a year-round comprehensive athletics program
- ? Providing nutrition and healthy cooking lessons for Liberty City's parents and children
- ? Increasing access to healthy meals for MCI participants, including dinner during after school programs and lunch throughout the summer.

The Health and Wellness Coordinator will also lead the following ongoing efforts:

- ? Vegetable Gardens - Expansion and maintenance of the vegetable gardens in several locations throughout the Impact Zone.
- ? Sharing Well - Expansion and maintenance of a youth-led free bike sharing program for children and youth.
- ? Fresh Food Co-op ?Expand upon the existing event, which currently occurs twice a month and provides children and families with fresh vegetables and fruits.

#### Parramore Kidz Zone (Orlando) \$95,000

Health and Wellness Coordinator ? PKZ will hire a full-time health and wellness coordinator and will also scale-up and begin measuring the impact of PKZ's health and wellness programs. This will include:

- ? Measuring participating children's health data (e.g. BMI, weight, height, blood pressure, health knowledge, youth fitness metrics)
- ? Engaging children in robust fitness activities including a year-round comprehensive athletics program
- ? Providing nutrition and healthy cooking lessons for Parramore parents and children
- ? Increasing access to healthy meals for PKZ participants, including dinner during after school programs and lunch throughout the summer
- ? Providing specialized wilderness education programs and park experiences for Parramore youth
- ? Expanding youth gardens in Parramore
- ? Designing and adopting a policy for healthy food and drinks served or provided at PKZ facilities

#### New Town Success Zone (Jacksonville) \$95,000

Community Garden - Expansion of the community garden program, which now consists of .05 acres donated to the community by Edward Waters College.  
(\$25,000.00)

Health-focused Camps - During summer month and break periods the NTSZ will hold camps that evolve around healthy eating habits and urban agriculture in the community garden sites. (\$35,000.00)

4-H Clubs - Hire a part time coordinator to start and organize all efforts relative to a 4H Club at each of the Title 1 schools in the neighborhood (S.P. Livingston Elementary and Eugene J. Butler Leadership Academy). (\$35,000.00)

The Ounce of Prevention Fund of Florida \$15,000

The Ounce of Prevention Fund will provide administrative oversight to ensure proper use of funds, and establish and operate a statewide system for monitoring sub-grantees, including tracking and reporting the quantity and quality of services provided by grantees, and the evaluation of program goals/outcomes.
