This is too authorize the Florida Fund for Minority Teachers, Inc. (FFMT) up to \$150,000 to purchase an online system that will improve and provide effective and efficient operations. The organization?s Board of Directors has vetted and approved a company that can provide the services. FS1009.605 indicates that the organization has a 5% administrative cap and can use up to \$100,000 of unallocated funds. As such, I am in support of submitting an implementing bill that would amend the current statute only for the 2016-17 fiscal year. The implementing bill would indicate that the organization remain at a 5% administrative cap and can use up to \$250,000. That change is inclusive of the one-time purchase of the online system. The organization is not seeking additional funding, but seeking approval to spend money that it already has.

NOTE: This is NOT a request for additional funding. The request is for a one-year statutory change to allow the FFMT to utilize up to \$150,000 in current funding to purchase an automated student information system which will provide efficiencies in retrieving student data relative to Minority Teacher Scholarship recipients. Current statutory authority which allows the FFMT to utilize 5% of the appropriation and up to \$100,000 for administration and the required training program would be retained.
