The Florida Goodwill Association is comprised nine autonomous Goodwill agencies, each serving the people of a multi-county region. These organizations share a common mission: to help Floridians overcome barriers to employment and become self-sufficient. Through Goodwill's services, people who depend on tax dollars become tax payers, reducing the burden on the State and empowering our program participants with dignity and self-worth. The 2006 Florida Legislature created Chapter 288.1097 identifying qualified job training organizations. To be eligible for funding under this Chapter, an organization must be certified by the Department of Economic Opportunity as meeting a strict set of criteria. In addition, the receipt of funds, from the current and past appropriations to the Florida Goodwill Association have been awarded only after verifying the specific requirements of their contract with the State have been met. These funds are provided solely to encourage and provide economic development through capital construction, improvements or purchase of equipment that will result in expanded employment opportunities.
