The Florida Health Equity Research Institute (FL HERI) was established in 2013 by the Florida Board of Governors to implement the Health Disparities Research Agenda for Florida through proactive collaborations among academic institutions, health care providers, government organizations, community-based organizations, and funding organizations. The specific goals include: a) increasing the development of health solutions that improve health of medically underserved populations; b) growing the pool of individuals from unrepresented groups for the health workforce; c) increasing external funding that will improve economic development in the state; and d) enhancing recognition of Florida as a leader in improved health outcomes. The need for FL HERI arises from the disproportionate disease burden among medically underserved populations in Florida and the lack of large, multi-disciplinary and multi-institutional efforts to improve health in these populations. Reducing this disease burden will decrease health care costs and improve economic viability in Florida. By developing multi-institutional and multi-disciplinary efforts we position our state to be much more competitive for federal funding for these types of programs. In 2013, Florida State University, the institution that serves as the host for FL HERI, received a non-recurring appropriation of \$400,000 to develop the infrastructure and statewide programs consistent with the above goals. Since the establishment of FL HERI in 2013, the following has been accomplished:

1. 13 state and private institutions have joined as partners including Bethune-Cookman University (BCU), Edward Waters College (EWC), Florida A&M University (FAMU), Florida Atlantic University of Florida (UF), University of South Florida (UF)

- 2. 10 member Steering Committee established, representing eight institutions (BCU, EWC, FAMU, FSU, Moffitt, UF, USF, UF)
- 3. 15 member Community Leadership Board identified, representing 13 communities in Florida and reflecting the ethnic/racial, economic, and geographical

diversity in the state

- 4. 350 students, faculty, health providers, community representatives and decision-makers have attended annual FL HERI Summits/Conferences
- 5. 587 high school and college (bachelor?s and master?s level) students statewide have participated in symposia on the health professions and biomedical careers or selected for summer research internships
- 6. \$11.6M in competitive federal and state grants submitted
- 7. \$5.9M in competitive federal and state grants received
- 8. Four faculty have received competitive FL HERI pilot research awards, representing FAMU, UCF, UF, and UF-JAX
- 9. Junior Faculty Scholars Program established with 2 faculty selected from UF as awardees

HERI is addressing some of the perennial problems in Florida--health disparities in medically underserved populations, lack of collaboration among higher education institutions and research centers, lack of community engagement related to the health of underserved populations and inadequate federal research funding. With the achievements in the first two years, they not only have far exceeded the performance metrics outlined in our application approved by the Board of Governors but also demonstrated an ability to bring diverse institutions and constituents together to address these broad perennial problems. However, in order to continue this success, they need recurring funding for staffing and other infrastructure to ensure uninterrupted service for our programs, especially those that provide outreach to students and junior investigators across the state. Thus our current request is for \$1,000,000 in recurring funds. The disbursement of funds would be divided accordingly:

- i. \$450,000 for competitive pilot research grants program to identify and test new innovations to reduce health disparities and to build capacity in investigators at Florida universities. This funding also would provide support for mentoring programs for junior investigators.
- ii. \$150,000 to host and grow participation in the annual statewide Health Disparities Summit for faculty, students, community representatives and clinicians; development of partnerships with national organizations; meetings for 10 member Steering Committee, and 15 member Community Leadership Board; and support for communication (website, reports).
- iii. \$100,000 to grow the number of students who are mentored in health-related STEM disciplines through symposia and summer research internships (stipends for student research interns and faculty mentors; rental of facilities for symposia, supplies).
- iv. \$100,000 for competitive pilot program to build research capacity and to strengthen research partnerships with community-based organizations.
- v. \$100,000 for support of research infrastructure, grant reviews, fiscal management.
- vi. \$100,000 for administrative staff and other support.
