The Situational Environmental Circumstances Model (SEC) is a conceptual framework designed to address educational attainment, juvenile delinquency and dependency involvement, cost reductions/avoidance and resource allocations relative to elementary age (3rd, 4th, and 5th grade) high-risk minority male youth. The SEC seeks to increase the effectiveness and efficiency of dependency, delinquency and educational services through sound research and targeted mentoring services.

Florida State University will serve as the fiscal and administrative agent with primary oversight of the research and implementation of the SEC Mentoring Model in collaboration with several other diverse higher learning institutions representing the north, central and southern regions of Florida. These institutions include Edward Waters College (Duval County), Bethune-Cookman University (Volusia County), Florida A & M University (Leon County) and University of Florida, St. Petersburg College, and Florida Memorial University (Miami-Dade County).

The project will consist of conducting cutting-edge research and providing documented mentoring services (exclusively by select college students attending the aforementioned institutions), as well as provisions for training, technical assistance, and monitoring services.

The overall goal of the project is to provide youth, families and social service providers with engagement strategies and activities within the communities which the youth reside. These strategies will include non-traditional engagement methods (i.e. Hip Hop, Skype, and various other forms and venues) to assist youth with understanding the importance of personal and educational success and achievement.
