The program provides student loan repayment assistance to eligible attorneys employed in the public sector. The attorney must be working full-time in the public sector in Florida, by the State or local government or Federal Government. The attorney must be earning less than \$65,000 and is not eligible for any other state, local or federal grant or private funds that assist in student loan repayment. The bill authorizes up to \$3,000 in loan payments annually for qualifying attorneys having at least 4 and up to 7 years of government employment. When an attorney reaches 7 years of employment, the amount authorized increases to \$5,000. When the attorney completes 10 years of service, loan payments cease. In addition, the bill authorizes payment of additional funds starting at earlier years for attorneys who are the ?best and brightest?

The program is intended to attract more attorneys to public service, and help government agencies retain attorneys, thereby reducing turnover and costs of repeated trainings. In addition, the program hopes to entice some of the top graduating attorneys across the county to enter into the public sector. Increasing payments based on years of service provides an incentive for attorneys to make a long-term commitment to public service.
