The \$1.5 million in requested funding will be used by the Friends Board to secure a permanent building for the CACB. The primary goal of the Friends Board is to secure a child-friendly facility that will house child welfare, law enforcement, and mental health professionals who evaluate the needs of abused and neglected children and their non-offending family members. The CACB is currently housed in a temporary location after the original site was repurposed by Wuesthoff Medical Center. In FY 2014 alone, the CACB evaluated 1458 children suffering from some form of abuse or neglect; 674 of these children ranged in age from birth to 6 years. Of the total number of children served in FY 2014, over 1000 were subjected to physical and sexual abuse. Under the supervision of the medical director, CACB staff members conduct medical exams and consultations, forensic interviews, specialized interviews, mental health counseling, and victim advocacy. A new facility designed specifically to serve the comfort and safety of these victims of crime is the top priority of the Friends Board and the CACB. Funds appropriated by the legislature will not be used to support salaries or programs. Our ongoing private fundraising and planned major gifts campaign will focus on facility improvements, if needed, and the outfitting of forensic exam rooms, interview equipment, and other resources necessary to serve the survivors of child abuse and sexual assault.
