Historically, the spring was a fourth magnitude, but, due to its reduced flow rate, it is now considered a fifth magnitude spring. The change in magnitude and an increase in nitrates are attributed to the decades of neglect. Many enthusiastic Gainesville residents wish to call attention to the plight of Glen Springs, see it acquired by the City of Gainesville, restored and used as a public park. It could serve as a nature park, passive recreational area and historical site. Request: The City of Gainesville is seeking \$3,400,000 to restore the springs to its natural state and allow for public access.
