\$300,000 of the requested recurring funds will used by the children's advocacy centers to provide direct services to children who have been abused or neglected. In 2014, Florida's CACs provided 141,782 direct services to 34,426 children who were victims of abuse or neglect. Direct services include case management and advocacy, therapy services, crisis intervention services, psychological evaluations, forensic and specialized interviews, and medical evaluations. Please see Attachment I, which provides justification for \$300,000 of the requested increase in recurring funds. \$750,000 of the requested increase in recurring funds will be used by the children's advocacy centers to implement a pilot project to provide carefully designed evidence-based prevention and intervention programs to reduce the likelihood of child maltreatment and provide safe and caring homes for children. The FNCAC will establish a pilot project comprised on six or seven children's advocacy centers that will use the recurring funds to either establish a new prevention program or to enhance an existing prevention program at the CAC. The CACs participating in the pilot project will be required to submit evidence that the prevention program they seek to establish or enhance is evidence-based and is capable of demonstrating verifiable outcome measures to measure the effectiveness of the program.
