Haney Technical Center is seeking funding to expand the Licensed Practical Nursing (LPN) Program. This program has a proven track record of success with a consistent state board exam pass rate of 93%, well above state and federal averages. Upon completion of the one-year program, students are employed by hospitals, long-term care facilities, home health agencies, walk?in clinics and medical offices. Program completers can expect to earn an average hourly wage of \$17.22 per hour in the local job market.

In order to meet this growing demand, Haney would like to expand the current program and add additional career pathways in other high demand healthcare occupations. The LPN program is housed in a small building across the street from Haney?s main campus. This request would allow renovation to an existing building on campus that would provide additional space to expand the current program and add more training opportunities for students to gain skills needed to obtain good paying jobs in the healthcare industry.

The approximate cost of the renovation is estimated to be \$970,000. The estimate includes additional costs for fixtures, fittings and furnishings for the additional classroom and lab space.
