The Hendry County Courthouse is a cornerstone of the Hendry County Community and, arguably the part of the historic fabric of Southwest Florida. Listed on the National Historic Building Registry, the Courthouse was built in 1926 and is still utilized as functioning office space for County and School employees including the Hendry County Schools' Superintendent. The funds requested will be utilized primarily of brick and mortar structural rehabilitation to address the water intrusion that is causing extensive damage to interior walls. In addition, some deteriorated wood soffits, fascia, and spalling concrete ceilings in the porch overhangs will need re-fabrication or repair. New flashings over 98 windows is required to eliminate the ongoing water intrusion. All preservation activities are done in accordance with the Secretary of the Interiors Guidelines. This project was submitted to the Florida Department of State for ranking under their facilities grant program and, on its merit, it ranked number nine on the list of projects submitted. This project will benefit the entire citizenship of Hendry County and remains a cornerstone to the history of Hendry County and Southwest Florida.
