The HBI Building Careers for Returning Citizens Program promises job readiness and career connections for eligible offenders on community supervision seeking vocational skills and employment opportunities. The goal is to assist participants to become gainfully employed within the community. The use of State funds helps train and place in employment an increasing number of offenders on community supervision annually. Ensuring that individuals earn wages and pay helps the State minimize public housing, food support, medical assistance and incarceration.

Over the course of FY 2016-17, approximately 180 offenders on community supervision will be connected, assessed and receive industry-recognized skills training through HBI?s programs. The program is designed to provide services to veterans, military personnel, and transitioning veteran offenders at HBI career centers located in West Palm Beach, Ft. Lauderdale, Miami, Orlando and Jacksonville (pending approval). Participants may earn one or more credentials in the following areas: Intro. to the Building Trades, Health & Safety: OSHA 10, OSHA 30, CPR/First Aid, Hospitality & Tourism and Work Readiness. Training occurs on average within six weeks depending on the services & certifications identified during the initial assessment. Job placement services including resume writing, interviewing techniques, and job development/referrals are provided throughout the program. Participants also receive follow-up services.
