Unfortunately, many families today find it difficult to ?tough love? their children, especially single parents, struggling to work and provide a healthy home environment, while confronting 21 st century issues like drugs, gangs, social media, cyber bullying, and peer pressure.

Law enforcement?s traditional role of arresting criminals has morphed into that of a parent, disciplinarian and mentor to todays? kids. It?s

Time To Be A Parent Again? seminars help parents find a balance between being a child?s friend and the Chief Law Enforcement Officer in that child?s life. Many parents are uninformed regarding the resources available to them, right now, to help them raise our next generation of parents.

It?s Time To Be A Parent Again? was launched by the Brevard County Sheriff?s Office in March 2014 working in conjunction with the local State Attorney and other family services providers. During 2015, there have been over 25 seminars, reaching approximately 1500 participants. Seminar topics include: Discipline? becoming your child?s personal cop; Warning signs your child may be headed for trouble; Techniques to monitor social media; Innovative approaches to solving disputes; Establishing boundaries, expectations of behavior; and, Imposing consequences for disobedience

Sheriff Ivey says ?As parents, it?s very important to remember that we are not just teaching discipline and responsibility, but are teaching the next generation of parents the importance of accountability and the value of appropriate discipline. If you are not the chief law enforcement officer in your child?s life someone will assume that role and influence your children. I know that it is hard to tough love your child but going

to visit your child in prison is even harder, and going to see them in a cemetery is truly unimaginable? that?s why it is important for you to have every tool possible to be your child?s personal cop.?
