The JAFCO Children?s Ability Center is an innovative state-of-the-art 4 acre campus that provides support to the entire family (parents, grandparents and siblings) and is currently serving over 300 children providing quality family enrichment, intensive case management, crisis support, resources and extended out-of-home day and overnight respite services to families raising children with developmental disabilities. The center is one of the only ones in the country where parents can actually schedule a vacation for up to two weeks per year, leave their child with us in our respite guest house and take their first vacation ever with their spouse and typical children, attend a wedding or just stay at home at rest. In 2016 the Center will also become a research institute with a recently funded agreement with Nova Southeastern University to measure and document the effectiveness of each and every program and service being offered. This exciting new venture will place the JAFCO Children?s Ability Center at the forefront of this type of research that will have a national impact on the world of disabilities given the alarming recent statistics that are revealing that an alarming 1 out of every 6 children born today will be diagnosed with a developmental disability (Autism Cerebral Palsy, Spina Bifida, Intellectual Disabilities and Prader Wili). With the support of a \$975,000 appropriation from the Florida Legislature through the APD and \$11m in privately raised capital donations, JAFCO constructed and opened a ?one-stop? center to address all of the needs of families raising a child ages birth to 22 with any developmental disability in one beautiful location with the goal of supporting and preserving the family and allowing children to live at home longer and avoid more restrictive and costly out-of-home placements.

One of the main goals of the project is create a plan for the child and the family for their future, specifically what will happen when they turn 22 and graduate from high school. Young adults with developmental disabilities lack the necessary skills to find and hold a job. Unemployment rates for adults with Autism are currently 92% (Autism Speaks, 2015). To help reduce this staggering statistic JAFCO is seeking \$1m in operational funding to provide an additional service to provide job skills training that will prepare eligible young adults with any developmental disability for the work force by teaching work readiness skills, life skills

and social skills. The program will target youth ages 14-22 years and is designed to teach skills that promote both employability and independent living and will focus on functional life skills that will allow each youth to gain skills to transition to adulthood including completing job applications, interviewing, office skills, laundry skills, culinary skills, functional communication training, social skills and working collaboratively. These skills will be taught using principals based on ABA (Applied Behavior Analysis) and will first be taught in a life skills lab setting at the Ability Center before being generalized to natural settings throughout the center and finally into the community. Each student will be assessed using the Functional Skills Assessment and an individualized program will be developed by a Board Certified Behavior Analyst in order to meet each student?s needs. JAFCO is an inclusion based agency engaging typical peers (high school and college students) as volunteers and mentors.

90% of the project expenses are for staff salaries to work with the children and youth. The remaining 10% will be spent on administrative costs and operational supplies for the program. The program serves 300 children ages birth to 22 and an additional 50 youth ages 14-22 will be served with this additional funding, mainly from South Florida (Broward, Dade and Palm Beach Counties). All of JAFCO services are open to children and families throughout the state of Florida. An intensive summer training component with an overnight option would allow families from other parts of the state to send their children to the program. The expected results are that 80% of youth served in the program will demonstrate an increase in job readiness skills, independent living skills and social skills. Families will report a decrease in stress and increase in parent satisfaction. Job procurement will also be tracked with a goal of 80% of all children who successfully complete the program being matched with a local job or volunteer position.
