BACKGROUND:

Old Kings Road is a high-traffic roadway that parallels and eventually merges with U.S. 1. The bridge targeted for replacement, which traverses Little Trout River, is functionally obsolete, and the balustrades are regularly damaged by vehicles due to the bridge?s narrow shoulders.

PROJECT DESCRIPTION:

The existing bridge will be completely replaced with a new structure that features wide shoulders to match other bridge structures on Old Kings Road. The Jacksonville City Council recently appropriated \$100,000 toward the completion of this project.

PROJECT TIMELINE:

To expedite progress on this project, the city is using the design/build method of delviery. Design is currently at 60 percent. The project could be fully constructed within a year following receipt of funding; construction could start concurrent with design completion.

Phase Estimated Time to Complete

Design and Permitting 3 months

Construction 8 months

BENEFITS:

Old Kings Road is a major thoroughfare in the northwest section of Jacksonville. Other bridge structures on this corridor were replaced with more modern facilities in the recent past; replacement of this bridge exceeded the funding available at the time. Due to the frequent damage resulting from the narrow shoulders, this bridge is costly to maintain as well as functionally obsolete.
