The non-recurring legislative appropriations request directly supports Governor Scott's "Let's Get To Work" initiative, in that it will add 40 new hi-technology jobs to Florida's economy. 100% of the appropriations request will be directed for the construction for a new roadway development improving ingress and egress through one of the state's smallest economically distressed municipalities (Town of Eatonville). This roadway will reduce traffic congestion to surrounding transportation arteries, thus increasing likeliness of attracting and retaining the best and brightest in establishing a hi-tech corridor with an average annual salary of \$44k.
