The dollars requested are to replace two old used vans owned by the Lealman and Asian Neighborhood Family Center (LANFC). One van is a 2001 Dodge and the other is a 2005 Chevy, both 15 passenger vans. The money requested is for 15 passenger vans as well. These vans are used to transport students from elementary and middle schools in the surrounding area to the Center in need of after school assistance (tutoring, homework help, and fun time). Parents do not have the ability to get them to LANFC. The vans also transport youth home. Forty students (40) are transported from schools to LANFC and 14 ? 28 are transported home. The majority of youth are from zip codes 33714, 33709 and 33781. However, others come from various places in Pinellas County. The vans are also used for field trips: 13 youth, plus staff and van driver, per vehicle. They also transport the sport teams to practices and games. The entire one-time request will be used to purchase two 15 passenger vans. The cost was based on research of sale price for 2016 from Ford, who is major producer of 15 passenger vans.
