MBF Child Safety Matters? is based on polyvictimization research. Polyvictimization refers to the experience of multiple victimizations of different kinds, such as sexual abuse, physical abuse, bullying and exposure to family violence. Research indicates that children who are victimized or maltreated in one way are at much greater risk of being victimized or maltreated in multiple ways. By focusing on polyvictimization, teachers, counselors, child advocates and other professionals who work with children can provide the best interventions and prevention practices. Thus, a program that educates children with universal safety rules and strategies is much more effective than programs focusing on one type of bullying or abuse.

The number of children reached with the MBF Child Safety Matters? program and related safety lessons in prior years are listed in the following table, as well as current and future year projections. For each year, the number of children enrolled in MBF Child Safety Matters? is based on actual orders placed by trained program facilitators; and the number of children reached with related safety lessons is based on student enrollment data from the Florida Department of Education. Related safety lessons are distributed to all public schools in Florida with kindergarten through sixth grade children.
