A ?no kill for space? shelter, CBHS is dedicated to speaking for those who cannot speak for themselves. We house and care for approximately 2,000 animals annually, with 1,800 finding their fur-ever homes.

CBHS has operated from its Merritt Island Adoption Center, which was donated, since June 2013. The Adoption Center is an extension of our shelter location in Cocoa, FL and houses small dogs and cats in free roaming rooms, providing an alternate location for homeless animals that do not thrive in a kennel environment. The purpose of our request is to fence in the property. The lack of fencing restricts the necessary ?play time? of our furry friends by having to be leashed, and never able to romp around freely due to the traffic that bustles by. CBHS envisions a fully fenced in facility whereby the animals can enjoy the beautiful Florida sunshine. This fencing will also provide safety for the animals and staff as this location is adjacent to a very busy roadway.
