Pinellas County is one of the premiere tourist destinations in the state of Florida. Pinellas County alone accounted for over 6 MILLION annual visitors to Florida with an economic impact of over \$8.5 BILLION dollars to states economy. One of the main attractions for visitors to Pinellas County are the beautiful Gulf Beaches. The City of Madeira Beach is a popular destination for beachgoers and even though small in size, accounts for over 2900 of those tourist dependent jobs in the county. John?s Pass entertainment facility is a major drawl for area tourism. As a shopping, dining, and charter destination the facility attracts tourists and local residents from around the state and country. The facility currently has street lamps and pedestrian crossings, however, those are not sufficient for the number of guests that crowd the area during peak seasons. The city has proposed to illuminate the walkways, landscape areas, and all crossing points with an innovative lighting solution to protect the nearly 30,000 visitors that come every season to John?s Pass. Without this funding, pedestrians will continue to be at danger of vehicle traffic in the area. The city is requesting that the state provide \$500,000 towards the projects total cost of \$1,000,000. The city will provide the remainder of the funds for the project. This project has been vetted by the City Commission and is shovel ready upon receipt of funds.
