Besides the \$1,000,000 State of Florida 2014-2015 appropriation, the City of Miami has obtained \$3,000,000 from the Miami Dade County GOB, \$500,000 from Gloria Estefan, and \$80,000 from AMX. The Munroe Marine Stadium is a unique, over the water, 6,600 seat venue with a floating stage. The historically designated stadium is in need of both structural and cosmetic restoration. When the project is completed it will host a variety of public/private events including; powerboat races, concerts, rowing races, special community events, and rental events. The statewide interests from an operating stadium include tourism, jobs, historic preservation, and additional revenue to the State of Florida. This venue will serve the entire State of Florida offering free and ticketed events that target Florida residents, tourists, the entertainment industry, the marine industries, religious groups, students, and art events as users of the facility.
