The National Navy UDT-SEAL Museum & Memorial is a major tourism and education destination in Florida. Located on the Treasure Coast at the beach birthplace of UDT-SEALs, it is the only site worldwide where SEAL history and operations enlighten the public. The museum needs a new facility to display artifacts in storage, accommodate items it receives daily, continue to show the SEAL evolving history and accommodate the number of tourists and students. The requested amount of \$300,000 will be used to construct a 20,000 sq. ft. architecturally dramatic building with exhibit areas, artifact storage/restoration facility, combined theatre/conference hall, office and food service. The museum will provide \$2,000,000 - \$4,000,000 for the completion of the interior and for the installation of exhibits.
