This funding would go towards funding a Science Literacy Program in Manatee County. In 2015, 55% of Manatee County 5th graders failed science. The Science Literacy Project will engage hands-on learning with complex STEM concepts to ensure a better understanding and retention of subject materials. Since 2009, over 75% of Nature's Academy students have demonstrated academic gains directly correlated with this project.

The Science Literacy Program and Nature's Academy have been recognized through recent awards, including a 2015 NOAA Marine Debris Program Grantee and the Florida Wildlife Federation's 2014 Conservation Educator of the Year. Due to the efficacy of this project, the School District of Manatee County has recently partnered with Nature's Academy to implement the Science Literacy Project district wide as a requirement for every local fifth grade student and teacher this year.
