NSCFF is a 501(c)(3) non-profit organization concentrating on Alzheimer?s, Parkinson?s, Multiple Sclerosis, and Stroke patients and their caregivers, with a mission of keeping patients at work, at home, and out of the hospital through comprehensive, coordinated, patient-centered and disease-specific care. Our project components are:

3T MRI Clinic, NSCFF Patient Education Programs, NSCFF Therapeutic Programs, NSCFF Social Work & Case Management, Miami Dade Stroke Consortium (MDSC) research and network, Medicaid Neurology Clinic, and development of a comprehensive healthcare facility with a robust and inter-active health information technology platform.

Our 3T MRI provides diagnostic imaging in an outpatient setting at a fraction of the cost of hospital MRIs. It also collects valuable neurological scans for future research.

Our patient education and therapeutic programs help patients and their caregivers better understand their chronic conditions, learn how to best manage them through proven therapies and exercise avoiding costly urgent care and emergency room visits.

The Miami Dade Stroke Consortium, an affiliated 501(c)(3) non-profit funded by NSCFF, is currently the largest acute stroke network in the County consisting of all six EMS fire rescue departments and fourteen stroke hospitals with a mission of improving stroke care and outcomes.

Our Licensed Clinical Social Worker provides comprehensive psycho-social evaluations, individual and group counseling, case management services, and develops educational and therapeutic programs focused on quality of life for these patient populations. Below is data on our social service, educational and therapeutic patient programs from FY 2014 and 2015.

Total patients-psycho-social evaluations = 47 /psycho-social interventions = 453

Total patients-support groups/group counseling = 45

Total patients- educational programs = 126

Total caregivers-educational programs = 27

Total patients-therapeutic programs = 70

Total patients in MDSC Registry = 16,000+

Working with a local FQHC, we have begun establishing the necessary infrastructure for a Neurology Clinic focused on Medicaid, the underinsured and uninsured patients with little to no access to neurologic care. This clinic may also serve as a training site for college and university health science students.

The ultimate goal is to establish a comprehensive care facility incorporating medical, imaging, pharmacy, rehabilitation, social services, education and research which will greatly impact healthcare delivery, the cost thereof, and patient outcomes. This will be an NCQA recognized neurological facility established as a patient centered specialty practice. It has been estimated that this comprehensive, coordinated model of healthcare delivery will save Medicare up to 10% per year through a reduction in hospitalizations, create over 400 new quality jobs while establishing a concentrated training site for university students and serve as a hub for innovative research, resulting in approximately \$163 Million in economic impact to the area. At the same time, funding is used for the development of a secure and robust health information technology system that serves as the backbone for effective coordination of services provided at the facility, secure patient information and data sharing, and outcomes research out of real-time patient encounters in order to continually improve on best practices creating a ?learning healthcare system?.

NSCFF serves also as a field office for FIU?s Robert Stempel College of Public Health and Social Work thereby assisting in the training of Master Level Social Workers. This program has also expanded caregiver education through our Alzheimer?s Caregiver Certificate course in partnership with Miami Dade College. The MDSC data bank will be offered to FIU?s medical school, public health and nursing students for use in public health research projects. Also, performance data gathered by disease group is applicable to these patient populations and data gathered is considered valuable by our education and research collaborators at FIU, the Miami Veteran?s Administration and Miami Dade College. Additionally, the use of the survey information collected from patients and caregivers assists NSCFF in developing educational programs geared towards addressing the knowledge gaps identified.

NSCFF receives grant funding from private grantor organizations, pharmaceutical companies, public donations as well as revenue from research projects. NSCFF has been approved \$7.5M from the Miami-Dade County GOB fund for infrastructure development. For FY 2015-16 we project \$805,000 in revenue from these sources, not including revenue from the Neurology Clinic.

FY 2016-2017 funds will be expended in the same categories as expended in 2014 and 2015 with the addition of providing funding for FIU research projects related to neurology as well as hiring more personnel for our Social Work department, physicians and nurses for the Neurology Clinic, and IT personnel. Attached is a proposed schedule of expense categories for projected state funding.
