Funds will be expended on a new well.

The goal is to provide a reliable potable water production well to replace Well 1 in order to protect the System's water supply in the event of the main well (Well 3) failure. Should Well 3 fail, Well 1 could not produce sufficient water and pressure to sustain the System's 870 customers, even with the forthcoming Interconnect with the Baker water system. Should the system fail, approximately 2,200 residents would be without water service, which would create a threat to public health and safety. The project will implement the legislative intent of chapter 373.016, F.S., chapter 373.705, F.S., and chapter 373.707, F.S. Project meets the intent of the Okaloosa County Future Land Use Plan, Natural Groundwater Aquifer Recharge element, Policy 1.2.

The benefit to the community will be the guarantee of sufficient water and water pressure for drinking water and fire suppression.

Pressure and volume readings on a weekly basis will be used to monitor effectiveness of the well.

The federal contribution of \$350,000 is from a USDA RD Loan/Grant.
