Provide tuition assistance to Florida residents enrolled in four of the medical education programs ? Osteopathic Medicine, Pharmacy, Optometry and Nursing. Funds are used to lower the tuition costs, providing direct assistance to students seeking degrees in these critical health professions. Funds in this request would restore funding level for this program to the 2007-08 levels of assistance. In 2014-15 (the last year funding was received), 440 students in osteopathic medicine, 527 students in pharmacy, 178 students in optometry and 730 students in nursing benefited directly from these funds by receiving a lower tuition cost. All of these students are Florida residents
