How will requested funds be spent?

Funding will be utilized for the reconstruction of the Crestview Courthouse. Air quality testing has found the current courthouse to have mold intrusion that would require a significant amount of demolition to rehabilitate the facility. Since the current facility does not have adequate space to serve the needs of the county the proper course of action is to reconstruct the courthouse on the same site in downtown Crestview. A site plan of the current design plan is available. The County has earmarked \$20M in capital funding of the \$25M needed

Identify expected program results and the expected benefit associated from the requested funds.

Reconstruction of the Courthouse will provide the necessary courthouse space for the citizens of Okaloosa County in a facility that isn?t laden with mold and asbestos materials. Initially constructed in the 1950?s, the current courthouse structure is not conducive to modern air conditioning systems or court service operations. The proposed reconstruction will remove all hazardous materials, provide adequate courtroom space and continue to serve as a fixture for downtown Crestview for many years to come.

Who will benefit from receipt of State funds?

The citizens of Okaloosa County. Funding from the state will supplement local funds for the reconstruction of the courthouse facility. The new site will provide safe access for the public, secure corridors and quarters for the judiciary staff and proper accommodations for everyone within the facility.

What specific measures will be used to document performance data for the project, if it receives funds?

The reconstruction of the courthouse is scheduled to be complete in approximately 2 years. Work performed as a result of the funding will be visible almost immediately.
