The Women?s Breast & Heart Initiative, Florida Affiliate is seeking support of \$250,000 for replication preparation costs and program expenses. In preparation for replication of our successful breast cancer and heart disease intervention in more Florida Counties and neighborhoods in South Florida, a spread strategy must be developed to ensure success. Requested funding in the amount of \$80,000 will support a 5-year strategic growth plan formulated by social innovation consultants. The plan will provide the details and roadmap necessary to transition the program to other targeted areas. It is necessary to codify the successful processes and protocols in replication manuals to ensure the program?s integrity as it is replicated in other areas of the state. Upon completion of the 5-year strategic business plan we can begin the spread strategy to expand our evidence-based model to two additional target markets: Orlando/Tampa and Tallahassee/Jacksonville. Funding in the amount of \$75,000 will support the Program Replication Manuals, which will include a 100-day engagement involving data collection, program implementation observation, data analysis, assessment report, draft operation and program manuals and revision and final manual delivery. The Program Replication Manuals will ensure the integrity of the program to new Florida markets and will ensure we have the same successful outcomes and impacts in our target communities. Funding in the amount of \$95,000 will support Program Implementation costs to serve 11,000 households, which include direct participant costs, volunteer mobilization, screening, event preparation and implementation for (8) month-long breast cancer and heart disease outreach campaigns.

During FY 2016-17, 11,000 educational door-to-door visits will be conducted in single family home neighborhoods with median incomes at 200-250% of the poverty level across three Florida Counties to be used as a basis for the codification of the program manuals. During this funding period, 3,800 households will receive breast and heart educational packages and more than 7,000 households will receive breast and heart educational door-hangers; 600 women will receive

breast and heart screening, and/or engage in physical activity and nutrition sessions and receive fresh fruit and vegetables along with healthy eating guides to promote good nutrition and a healthy lifestyle.

During this process, more than 900 individuals from colleges and universities, as well as civic organizations and corporations will be trained and deployed to conduct door-to-door outreach and gain a valuable skill set of leadership, team building, organization, public speaking, and problem solving. The skill set gained through participation in our program, benefits our community as skills gained benefit professional and personal lives.

Underserved women who are uninsured, underinsured in Florida will benefit from State funds by receiving breast cancer and heart disease education, wellness and prevention strategies, along with access to early detection screening and navigation to requisite care when needed.

Students from South Florida campuses and individuals from corporations and civic organizations will benefit from state funding as they will be engaged in community service, learn key strategies to reduce their risks from breast cancer and heart disease and share that information with their families, and corporations will be engaged in civic responsibility.

Collaborating hospital and medical partners will be connected with women in their catchment areas to provide prevention and early detection services which ultimately reduces the burden of the adverse impact of breast cancer and heart disease in our society.
