South Florida Museum (SFM), the largest natural and cultural history museum on Florida's Gulf coast, is home to Snooty the manatee and is a Stage 2 rehabilitation facility where sick and injured manatees continue to recover after their condition is stabilized at one of the state's three critical care manatee hospitals. SFM's manatee exhibit is both a tourist attraction and environmental education provider.

The requested funds will be used for architecture and engineering planning and design for the upgrades, equipment and/or construction costs. Capital improvements will include, but are not limited to: a new lift system to increase efficiency and safety when transporting manatees on arrival and for release, and between pools; a new chiller and heating system for the manatee pool and additional air conditioning infrastructure, etc.
