Primarily, this funding will be used to supplement operations college-wide and to partially fund initiatives relating to increasing the completion and retention rates at the College in an effort to meet the demands of the new performance funding model. With the increasing enrollment, operating costs necessarily increase; these costs include, among other things, the need for additional student support staff such as academic and financial aid advisors, career and testing services and of course, faculty. In prior years when PHSC has grown, there have been insufficient state funds to meet the needs and, as a result, PHSC became the lowest funded college in terms of needs being met. The special awards given in the 2014 legislative session to a select number of colleges together with the base funding put at risk through the performance funding model will again put PHSC, the fastest growing college in the state, near the bottom in terms of needs funded.
