In 2014, the 1st Phase of the Slip Walls Replacement and Capital Improvement Project for the St. Johns River Ferry was funded from a \$3.9 million FTA Passenger Ferry Grant, matched by \$1,000,000 appropriation by the State.

The St. Johns River Ferry's slip walls are at the end of their useful life, and significant repairs are needed, beyond what is being currently accomplished with the Phase 1 FTA Passenger Ferry Grant. This project will rebuild the slip walls, increase reliability of service by utilizing a lower maintenance design, and lower costs and service interruptions for repairs. All funding will go to the Capital Project and associated expenses.

Expected benefits are:

- 1. Support our Military with efficient transportation opportunities to and from Naval Station Mayport.
- 2. Provide safe and reliable infrastructure for our community residents, workforce and visitors.
- 3. Encourage economic development and revitalization to the immediate surrounding community along this section of the A1A corridor.

The direct beneficiaries of this project are the 475,000+ riders annually, including North Florida residents, the workforce community, Military personnel at Naval Station Mayport and tourists. In the third quarter of 2015, the St. Johns River Ferry had record breaking numbers, serving 251,337 vehicles, and 480,382 passengers.
