In 2015, the Legislature appropriate and paid to Protective the amount of \$181,025 which represented the amount of unamortized tenant improvement funds accrued to July 1, 2015. The lease termination date was November 15, 2013 and the scheduled expiration date was February 29, 2016. That means that 27.5 months of term remained on the lease and the time of termination. The amount appropriated in 2015 was \$181,025 which represented 19.5 month of the total of 27.5 months of remaining term. Given that the Legislature appropriated and pain \$181,025 of the total amount of unamortized tenant improvements which was \$255,292, the balance remaining is \$74,267. Stated alternatively, the balance of the unreimbursed Tenant Improvement funds that accrued from July 1, 2015 to the Lease termination date of February 28, 2016 (8 months of term) is: \$255,292 - \$181,025 = 74,267. Which can be calculated as follows: 8 months/27.5 months x \$255,292 = \$74,267.
