This funding will allow for the development of vacant and under-utilized parcels along State Road 7, this will bring the properties into viable commercial development and creating jobs. The City of West Park proposes to develop parcels for the purposes of future commercial development within a blighted area of the City (State Road 7, which is 441). Our objective is to eradicate the appearance of slum and blight by creating opportunities for economic development for businesses and fostering job creation for our residents. Presently, the major characteristics of the immediate area include vacant land, demolished buildings and dilapidated facade. The proposed development of the parcels will cure urban blight create jobs that will entail gainful employment positions such as customer service, retail, banking, food service and much more. In addition, management positions will also be created as a result of this commercial acquisition and business development. It is anticipated that a potential of 78 jobs will be created as part of this project within this region of Florida. These jobs will entail long-term and short-term, as well as full-time and part-time. The project will also help stimulate the local economy by adding additional properties onto the tax roll.
