Each of our scholars begins with \$1,000 their freshman year of college and end their senior year with a \$4,000 scholarship. The total students receive is \$10,000, if they stay engaged in their community and the foundation. Also, relationships are built between the scholars and Foundation mentors to assist with networking, internship and leadership guidance.

80 students have participated in the program since 2011 to date. The Randy Roberts Foundation is housed in Lakeland, FL.
