This effort includes the downtown district and the U.S. 301 corridor, also known as Gall Boulevard. Working with FDOT, the City agreed to a trade of right-aways with FDOT. The City has had several visioning sessions and processes, the City has set as its goal the objective of enhancing a "sense of place" based on historical recreations and manifestations.

Funding is for the design of the project. Encompasses an 18-block area, from 16th Avenue to A Avenue and wholly within the city's Community Redevelopment Area. Design of the project has an estimated cost of \$700,000 or 10% of the total for the project. The appropriation being sought is for assistance on the design phase of the project. The City of Zephyrhills is willing to match the full \$700,000 with local funding.
