Indian River State College seeks \$12,665,916 in non-recurring, fixed capital outlay funding for the renovation and remodel of its Industrial Technology facility (O-Building/Facility No. 8) on the Main Campus in Fort Pierce. This funding will modernize a 46 year-old, 26,000+ sq. ft. structure which houses vital training programs in occupational and trade areas, including Smart Manufacturing, HVAC, Automotive Technology, Welding, Electrical Systems, and Construction.

Instructional space, equipment, and laboratories now lag behind 21st century expectations, and must be enhanced to meet the evolving demands of these respective industries. As the primary provider of educational and workforce training on Florida?s Treasure Coast, and a state-designated career and technical center, this facility is critical to addressing regional needs in industrial-related occupations. Moreover, current limitations of the facility create spatial deficiencies for student enrollment in these programs. With a modern overhaul of the space, capacity could expand beyond the approximated 120 student stations to serve more students and produce more graduates in the aforementioned fields.

The funding allocated to the project would not be associated with new IRSC positions or salaries, nor any new operational costs. Estimated capital outlay costs are available as part of IRSC?s College Improvement Plan (CIP3) approved and submitted annually by the IRSC District Board of Trustees. This project is the top priority on the College?s CIP and has been included as a state funding request since 2005. Furthermore, need for the project has been expressed by the private sector through countless business partners with the college, including FPL, Wal-Mart Distribution, Piper Aircraft, countless automotive dealerships and small manufacturers, and many others.

Not only will this Ren/Rem greatly extend the life cycle of IRSC?s O-Building through electrical, HVAC, and structural repairs, it will offer the State of Florida a solid return on investment. According to a recent 2012/13 EMSI study, IRSC has a rate of return estimated at 7.7 percent and a benefit/cost ratio of 2.4; at this approximation, the \$12.6 million in fixed capital outlay invested could potentially return over \$30.2 million to the Treasure Coast region, the State of Florida, and the IRSC students who will receive modern training and subsequently earn high-wage employment in industrial fields.
