The renovation and upgrade of Florida Southern's Greenhouse will address shortcomings and upgrade existing greenhouse to state citrus nursery standards so that we can be better prepared to teach and train future leaders in citrus in all areas of production in the correct nursery setting. Improving productivity will be a key factor in battling greening in Florida; new planting and propagation techniques along with growing and protecting citrus stock from future diseases will continually evolve so our graduates need to be prepared to support this continually changing industry. We will also address the shortage of college graduates prepared to work in the citrus and agricultural industries. Their education, training and skills will be much needed to work with citrus growers and nursery owners to grow and plant the tens of thousands of trees that will be needed to replace groves destroyed by the greening disease. In addition, we hope to increase numbers of qualified college graduates to fill leadership roles within the citrus industry as more of our leaders are retiring over the next few years. Finally, by creating a new histology (plant and animal cell biology) lab, we will be able to expose our citrus and science majors to the latest research method and techniques to grow cells, and manipulate and analyze cell responses to environment changes and diseases, and chemical exposure which will enable our students to work in multiple fields of science, agriculture and citrus research.
