Additional cabaret theater shows numbering 156 will increase the number of patrons who are dining. Annual revenue from dinners will be over \$1.5 million equating to state sales tax revenue of \$110K every year. Facility is 33 years old and is need of a new arrival and Parking solutions so many more patrons can be entertained and accommodated with the expansion and improvements.
