IST will be located at SFM, taking advantage of a new, STEAM-focused wing - the Mosaic Backyard Universe - being built to provide children, families and students with the opportunity to explore and understand the world around them in a familiar setting: a typical backyard.

USFSM and the SFM have a strong history of collaboration through the Center for PAInT. SFM's new IST leverages this established relationship and should allow for increased undergraduate opportunities.
