History of Project

? June 2014, Legislature & Governor approved \$2.5 million to build a technology related Accelerator in Naples and an Agribusiness/Culinary related Accelerator in Immokalee. Collier County and private sector pledged a 5 year match. Collier has already appropriated \$589,500 to the project, with over \$200,000 in private sector donations.

? 6 months (mid-December 2014) elapsed prior to DEO releasing any funds for project that involved significant construction and remodeling. As a result legislature approved a reversion and reappropriation of the approximately \$1.8 million in unspent funds so the project could be finished as originally planned. Reappropriation was vetoed.

? Naples Accelerator opens in 10,000 sq. ft. in August 2015 with reduced staff, services, equipment. Immokalee Accelerator project put on hold.

? Collier County and SWFL Delegation approve a 2016 legislative request for \$5.5 million to fully restore the Immokalee Accelerator project, and add 10,000 sq. ft. of office space in Naples.
