A segmented submerged breakwater will be installed with or without the placement of additional sand. The segmented structures will be used to mitigate erosion for up to 2,000 feet of shoreline located along a given segment between DEP monuments R-010.5 and R-105.5 (4,000 feet). This will reduce shoreline erosion without causing adverse effects to the adjacent shorelines; extend the time between each nourishment projects thus reducing costs; increase storm protection to upland structures and infrastructure/enhancement to aquatic habitat and be environmentally friendly; the construction will provide recreational opportunities due to a near shore artificial reef of new fish habitat; construction by local work force will add to the local economy growth and recovery; and this will develop a cost effective erosion control structure that can be applied to other areas of the State. A monitoring program will be developed and implemented by Gulf County, as approved by the State of Florida DEP to evaluate the performance of the project for three years.
