This is a new building which will replace a 41 year old building that was originally designed for storage of student records. Please refer to attached narrative for details on expenditures.

?Enhancing application, admission, advisement, financial aid and support processes in a centralized location will minimize the number of students who struggle due to lack of advisement, poor academic and career planning, or simply confusion about processes. Retention, completions, degrees and certificates awarded will increase.

?Unique shared student services model between Seminole State College and the University of Central Florida, promoting articulation into higher-level degree programs, and corresponding higher-level employment opportunities.

?College received \$250,000 in 2009-10 to develop the program plan for this project. The \$11,737,000 allocated in 2015-16 will allow for completion of the design and partial construction. In total, the project includes approximately 69,400 gross square feet of space to house enrollment services, academic advising, registration, financial aid, student records, testing and disability support services. Total cost of the project through all phases is estimated at \$24,478,933.

?The existing 27,000 square foot facility was constructed as a data storage building in 1974 when Seminole State enrolled 14,094 students. We now serve over 30,000 students? a whopping 118% increase. The building is simply inadequate to handle that growth.

?Seminole State is 61% short of the recommended student services square footage for a college our size.

#### Overview ? Current Service Locations

The need to better serve students has been a major factor contributing to the high priority of this facility on our overall funding list. The need for more convenient and integrated services located in a single facility will provide the support services students need to be advised and enrolled in programs for successful learning outcomes and job placement.

## Overview ? Centralize Services Facility

The new Student Center located in the center of the campus, as shown below, will have a significant impact on the campus learning climate and provides students with easy access to support services including advising, enrollment, student life, and career counseling.
