In addition to being the largest homeless service provider in Northeast Florida, the Sulzbacher Center is also the only Jacksonville shelter that keeps homeless families together. Funds from this appropriating request would be used to construct a new facility to provide a family environment separate from the general homeless population. Currently, women and children are housed in the same facility as homeless males.

The need for a new facility to house destitute families has never been greater:

- 25% of all homeless families in the United States live in Florida
- 1,900 homeless children attend school in Duval County
- Families are the fastest growing sector of the homeless population
- Over 120 destitute families are already on the waiting list for services at the current Sulzbacher facilities

Once constructed, the Sulzbacher Women & Children's Center will feature the following components:

- Semi-private female respite rooms
- Permanent housing units
- Medical Clinic
- Pediatric Optical Clinic
- Daycare Facility

- Serving Kitchen/Dining Hall
- Playground
- Park/Community Garden
