The Diversity Initiative (TDI) has identified a significant need for Job Carving and Employment Customization Services for individuals with the most significant disabilities as traditional job placement techniques and approaches are failing to make the connection and deliver meaningful employment opportunities to thousands of unemployed job seekers with significant disabilities.

The proposed Job Carving and Customization Program will work towards creating job opportunities for individuals with significant disabilities by evaluating the needs of employers; strategically identifying appropriate positions in their companies; and integrating talent in such a way that enhances workplace productivity while improving a business?s bottom line. These targeted services would be provided in conjunction to person-centered career readiness assistance and job retention support to promote success in employment.

The measures that will be used to identify that the state funds are being used appropriately is by increased placement of persons with disabilities in viable jobs. By allowing us to place more individuals with disabilities in the workforce we can decrease the unemployment rate in these three counties and help to decrease the VR waiting list. As an agent of VR we operate on a performance based contract. Thus our contract works on the amount of individuals we place into stable

employment and then keep in stable employment. So the data will be used to show that with this customized job carving program we are able to place more individuals into stable jobs,. Thus, reducing the unemployment rate for individuals with disabilities.
