The National Flight Academy, a wholly owned subsidiary of the Naval Aviation Museum Foundation, has never received appropriates from the state budget. In order to increase its capacity for the delivery of science, technology, engineering, and mathematics (STEM) educational programs, the National Flight Academy is requesting \$1,231,632.00 in state funding for a fixed capital outlay project. The entirety of the request involves non-recurring funds that will be expended on technological components for the facility?s Joint Intelligence Centers, Joint Operations Centers, Ready Rooms, Hangar Bay as well as various furnishings for the facility?s berthing staterooms.

One hundred percent of the funds will be expended on capital components for the facility. Technological components include computers, audio equipment, Smart Boards, task trainers, furnishings, printers, televisions, radar station monitors, drone stations and Triad X-12B flight simulators.

Currently, the National Flight Academy offers year-round educational programs serving students in grades K-12. Educational programs span from one day ADVENTURES to 6 day DEPLOYMENTS that immerse students and adults in a naval aviator experience which is utilized as the delivery method for STEM educational concepts as well as 21st century skill development such as teambuilding, critical thinking, public speaking, and chaos management.

At the current capacity of 144 and only being operations since the summer of 2012, the National Flight Academy has served over 5,000 students to date. If the National Flight Academy had the ability to increase current capacity to 216 per week, it is projected that it could reach over 5,000 students annually given its current program turnout rate. The National Flight Academy does not expect matching funds from other sources with regards to this capital outfitting project at this time; however, once the facility is outfitted with the aforementioned capital components, no further state appropriations for this project will be required. While 72% of participants are from the regional area (Escambia, Santa Rosa, Okaloosa) the program has also reached students in 44 states and 7 countries from

around the world.

Should no State funds be secured, this project will need to find various donations as a funding source for expansion.
