Funding will be used to develop the Cutler Bay Economic Development Plan. The Town will hire a professional consultant to facilitate the development of the Plan. The project will include a series of public involvement meetings, a survey to determine the Town's needs, and the establishment of an "Economic Development Advisory Committee" to assist with the development and monitor the implementation of the plan once adopted.
