In 2014 the Town of Lantana gave up its recreation fields and State lease on the former AG Holley Hospital site.

The Town of Lantana now leases approximately 16 acres from DEP nearby for the management and operation of recreation fields, community center, police substation, recreation center, etc along with other related uses necessary.

The site also includes a 10,000 sq. ft. building that needs renovation including mold remediation in order to be utilized.

It should be noted that this is technically a State owned building. The Town has a long term lease on the land and building but ownership, along with any improvements to the building, would remain a State asset.

The renovation of the building would be within the State Board of Trustees Lease #4575 to the town of Lantana, located at 901 N 8th Lantana, FL 33462, Section 33, Township 44 South, Range 42 East, in the Town of Lantana, Palm Beach County.
