As there is a one-to-one relationship between a better prepared teacher and improved student achievement, the beneficiaries are teachers with out-of-field and not-highly-qualified assignments, their students and all stakeholders including at-risk schools, principals, parents, taxpayers and the state. Research also shows a relationship between better qualified teachers and the future income of their students. The better the teacher the better the lifetime income prospects for their students which is a benefit to economic development for the state.

Funds will be used to pay tuition and fees (course material, Florida Teacher Certification Exam prep and any FTCE fees) for out-of-field and not-highly-qualified K-12 teachers in the Expert Systems for Teachers Series of 100 subject-specific online courses, offered by UNF and UF, to better prepare them for new assignments. A grant of \$4,000,000 will serve 2,666 enrollments of the over 20,000 K-12 teachers with out-of-field and not-highly-qualified assignments each school year.

Underlining the need for the grant program, only 27% of K-12 teacher enrollees from 34 school districts passed the pre-test before instructional support and mentoring support was provided through the grant. Test scores among teachers enrolled showed an average improvement from 58% pre-test to 90% post-test. This practical, economical, ?just-in-time? management program addresses the problem of the unequal distribution of highly-effective teachers by answering the immediate needs of teachers unavoidably assigned out-of-field.
