This request for new recurring funding will be used primarily to hire and support additional faculty and staff throughout the USF System (USF, USF Health, USF St. Petersburg and USF Sarasota-Manatee) in an effort to boost workforce development specifically in STEM and health fields. Already a state leader in these fields, the USF System is poised to strengthen linkages with the business communities in Tampa, St. Petersburg and Sarasota-Manatee by (1) boosting its STEM/health educational preparation programs and (2) expanding STEM/health entrepreneurship and research. The \$9 million requested would be shared among the main USF campus in Tampa (including USF Health), USF St. Petersburg and USF Sarasota-Manatee in ways that will meet each institution's individual needs while maximizing shared strengths, goals and opportunities to meet the distinctive needs of the local community. The requested distribution of the \$9 million in new funding is: 1) USF Sarasota-Manatee: \$2 million; 2) USF St. Petersburg: \$2 million; 3) USF (Tampa): \$2.5 million; 4) USF Medical Center (USF Health): \$2.5 million.
