Project Description: In 2013, the legislature created section 1001.7065, F.S. establishing a partnership between the Board of Governors and the legislature to elevate the academic and research preeminence of Florida?s highest performing state research universities. As of July 1, 2013, the University of Florida and Florida State University met the performance requirements of the law and received Preeminent University designation from the Board of Governors.

? University of Florida

When looking at the rankings public AAU institutions, UF?s peer group, the University of Florida is among the Top Ten on 22 important benchmarks. UF?s challenges relate to the availability of faculty and support. The \$10M new request for recurring funds will be used to hire an additional 50 faculty members to supplement the 90 faculty that have been hired to date due to Preeminence funding received in the past. Using Academic Analytics, these faculty hires have been made in strategic areas based on UF?s Strategic Plan for Preeminence. That plan includes more than two dozen interdisciplinary focus areas spanning health, agriculture, computing and education that are shining a light on world challenges such as biodiversity, drug discovery and development, food security and data analytics. UF will continue to invest in areas that the National Science Foundation has identified as important: understanding how the human brain works; resilience in nature and the man-made world; and the interdependence of food, energy and water.

Examples of Return on Investment:

Increase in college and program rankings nationally- since the inception of this program UF has already risen to Top Ten Status in the areas of Systems

Engineering, Industrial Engineering, Plant Pathology, Wildlife Ecology, and Applied Psychiology;2) Increase in externally-generated research and development-although not all of the 90 hires are physically on campus yet, to date the new faculty that are have generated 3 dollars in external funding for each 1 dollar invested by the state; additionally, UF?s external research funding now is at a record \$707 million dollars; 3) Increased private fundraising has been launched to support the colleges- the Preeminence designation was the impetus for a gift from the Wertheim Family totaling \$50M to UF?s College of Engineering, the largest cash gift in UF?s history which is the catalyst for the largest expansion of the 105-year history of UF engineering.
